

Liability Waiver and Agreement for CozyDaysDogBoarding

This Liability Waiver and Agreement ("Agreement") is made between **CozyDaysDogBoarding** ("Service Provider") and the undersigned pet owner ("Client") regarding the boarding and care of the Client's dog(s).

1. Acknowledgement and Assumption of Risk

I, the undersigned Client, understand and agree that:

- CozyDaysDogBoarding provides a home-based, cage-free dog boarding environment, and while every precaution is taken to ensure the safety and well-being of all pets, there are inherent risks involved in pet boarding and care.
- Dogs may sustain injuries during play, such as scratches, bites, or sprains, or experience health issues due to pre-existing conditions, stress, or unforeseen accidents.
- CozyDaysDogBoarding cannot guarantee that my dog will not become injured, fall ill, or experience adverse reactions while in their care.

2. Release of Liability

I agree to release, indemnify, and hold harmless CozyDaysDogBoarding, its owners, employees, and affiliates, from any and all claims, damages, or liabilities arising from:

- Injuries, illnesses, or accidents sustained by my dog while in their care.
- Loss or damage resulting from my dog's behavior, including aggression or interaction with other dogs.

3. Emergency Medical Care

- In the event of illness or injury, CozyDaysDogBoarding will make every effort to contact me immediately. If I cannot be reached, I authorize CozyDaysDogBoarding to seek veterinary care at their discretion.
- I accept full financial responsibility for any veterinary expenses incurred while my dog is in the care of CozyDaysDogBoarding.

4. Health and Behavior Requirements

- I confirm that my dog is up-to-date on all vaccinations, including rabies, distemper, and bordetella, and is free of fleas, ticks, and contagious diseases.
- I confirm that my dog does not have a history of aggressive behavior or pose a danger to other animals or people.

6. Agreement Termination

CozyDaysDogBoarding reserves the right to refuse or terminate services at their discretion if my dog's behavior is deemed dangerous or disruptive to the safety and well-being of others.

7. Acknowledgment and Agreement

By signing this Agreement, I acknowledge that I have read, understood, and agree to its terms. I affirm that I am the legal owner of the dog(s) being boarded and that I have disclosed all relevant information about my dog's health and behavior.
